

Summer Enrollment Blitz Contest Rules:

1. Participants must qualify to participate by meeting the following criteria:
 - a. Be Active
 - b. Be in good standing with the company
2. The Summer Enrollment Blitz Contest period will run from August 1, 2019 at 12:00AM MDT through August 28, 2019 at 11:59PM MDT.
3. Point accumulation will occur weekly, restarting each week. Individual weeks within the contest period will be as follows:
 - a. August 1, 2019 at 12:00AM MDT to August 7, 2019 at 11:59PM MDT
 - b. August 8, 2019 at 12:00AM MDT to August 14, 2019 at 11:59PM MDT
 - c. August 15, 2019 at 12:00AM MDT to August 21, 2019 at 11:59PM MDT
 - d. August 28, 2019 at 12:00AM MDT to August 28, 2019 at 11:59PM MDT
4. All qualified, new enrollments that take place within the above contest periods will be eligible. Points are awarded to the enrolling Participant for eligible registrations of new Enrollees with active subscriptions, as outlined herein, and given at a ratio of one (1) point for each new, qualified Enrollee.
5. Qualified Enrollees are defined as any new Kuvera Distributor/Customer who registers and purchases an active monthly subscription (excluding APEX) and maintain an active subscription for a minimum of one (1) additional month after the initial registration month.
